Throughout the past year, Citizens League events have connected Minnesotans to each other and to policy issues that matter to them. We aim to **engage** people eager to participate in their communities to see public policy as a way to drive change. Leading with a multi-partisan approach, we build awareness of issues and policy solutions. Our Mind Opener webinars, Interconnected Rural-Urban Conversations, and Civics@Work policy learning sessions covered a wide range of topics such as:

- · Minnesota's changing environment and climate
- · Challenges facing rural and urban EMS systems
- Run, Serve, and Lead: What it's really like to serve in local elected office
- · How do I talk to my neighbor again?

Our annual Civic Celebration demonstrates the power of bringing together a diverse array of civic leaders, policy thinkers, and community builders. In 2023, over 300 people gathered to honor Kathleen Blatz, former Chief Justice of the Minnesota Supreme Court and Minnesota State Legislator, and Edwina García, former Minnesota State Legislator and Richfield City Council Member.



In 2022, over 1,830 people participated in Citizens League events, a 28% increase over the previous year.

In the eight years of the Capitol **Pathways** program, over 90 organizations have partnered with Citizens League to host interns, bringing young leaders into policy work in a variety of settings. To date, 260 Capitol Pathways student interns have had the opportunity to build skills and relationships and to bring voice to

policymaking.







ACTIVATE

Deeper participation of people in policy



Citizens League activates participation

by helping people explore how they can be involved in shaping policies that impact their communities. Citizens League's approach to building and supporting networks of leaders is rooted in our conviction that everyone should have access to opportunities in public service and policy, and our government should be representative of our diverse communities.

New this year, Citizens League developed an in-depth workshop to help people understand how they can connect and engage in the Minnesota legislative process. We successfully piloted this training with the Saint Paul & Minnesota Foundation community impact team and look forward to sharing it with other groups.

Our Capitol Pathways program supports cohorts of Black, Indigenous, People of Color (BIPOC) college students in paid internships with government offices, nonprofits, corporations, and law firms. This year, 32 energetic young leaders from diverse communities participated in Capitol Pathways internships, impacting the legislature and policymaking community by bringing new voices into the space and changing the face of who is at the Capitol.

WHAT WE STAND FOR:

While Citizens League has had a role in Minnesota for over 70 years, there have been monumental changes in our world and in our communities. Here's how we



approach our work today – a reflection of discussions with our staff, board, program participants, and community partners.

We encourage:

- · Curiosity, listening, and learning.
- Seeing humanity in each person. Avoiding labels and assumptions based on race, gender, political affiliation, and more; while acknowledging that differences matter.
- Being engaged to the best of one's ability, even in difficult conversations on tough issues.

We discourage:

- · Binary arguments and framing: "us vs. them", "win or lose," blaming, finger pointing.
- Derailing or disrupting a process that has been designed to be as inclusive as possible.

We will not accept:

· Demonizing or dehumanizing people and groups.

Why does equity matter?

Equity means everyone has an opportunity to thrive, but what one person needs to thrive may be different from what another person needs. Intentionality is required to include those communities where policy decisions may have an outsized impact, but who may not typically be at decision making tables. Equity is not only about race - depending on the issue, those most impacted could include rural residents, women, young people, older adults, individuals with disabilities. or others. The League will use a comprehensive approach to strive for intentional and sustainable inclusion that is reflective of all communities and people impacted.

What does "nonpartisan" mean for Citizens League?

We believe the inclusion and validation of multiple perspectives creates stronger community solutions. We support bridging political divides. We create space for people of different perspectives to exchange views, build relationships, and engage in civic life and public policy.

IMPACT

Critical policy issues using our unique approach

Citizens League **impacts** critical policy issues both as a trusted source of data, and through inviting community input to develop policy recommendations. Last year, Citizens League completed a report about why people run, decline to run, remain serving, or step down from local elected office, and the impact on local government. This work was unique in many ways; we explored the motivations of local candidates from a multi-partisan perspective, analyzed themes, and recommended ways to support candidates for local elected office who are broadly representative of communities.

We are currently developing a new Connect + Impact policy engagement and collaboration model to provide ways for even more people to be involved in learning about public policy and seeing their role in it. A group of Capitol Pathways alumni worked with staff as co-designers to formulate the basic structures of this new initiative. We are continuing to get input from a variety of stakeholders to refine the program design, and we plan to pilot our new Connect + Impact policy groups later this year.



Our report, **Serving in Local Elected Office**, summarizes what we learned from surveys and interviews with 80 local civic leaders in the Twin Cities Metro.

BUILD Organizational and financial sustainability

Citizens League continues to **build** a strong foundation by investing in staff and infrastructure to support our work into the future. A broad mix of contributions provides flexible funding to support our mission and makes a difference in informing and engaging people and making our

communities stronger. This year we revamped the organizational membership model to be better aligned with our partners' needs to engage their employees in more meaningful ways. In 2022, staff implemented monthly "DEI Dives", in which we chose an article, podcast or video with a Diversity, Equity, and Inclusion theme and discussed how it applied to us and to our work.

In addition to our small but mighty team of six staff members,

undergraduate and graduate school student interns help us to move the work forward. Through mentoring and robustly supporting student interns, Citizens League is "walking the talk" of preparing the next generation of policy leaders.
